

The Technical division headed by the Technical Director will ensure the development of the game is sustained and properly managed.












ORGANISATIONAL CHART

FABD STRUCTURE







The AFC Executive Committee has approved the AFC Enhance Programme which also included the AFC Enhance Member Association Advantage Programme and the AFC Enhance Member Association Extra-Time Programme.

With both programmes, the FABD has the potential to receive an allocation of USD\$200,000 annually for the development of football in Brunei Darussalam and in light of this, FABD will activate tender processes for the infrastructure project under the AFC Enhance Programme for the floodlight upgrades.















GOVERNANCE

FABD is looking to introduce a revised Disciplinary & Ethics Code of the FABD along with the Travel Policy & Guidelines and the Child Protection & Safeguarding Policy in the near future.

The association is protected through the Statutes and codes of FIFA, the AFC and the AFF. The FABD Secretariat has produced guidelines, regulations and policies to safeguard the sustainability of the FABD and the stakeholders.

Apart from the financial regulations which include; Payment Policy & Procedure, Petty Cash Policy & Procedures and the Procurement Procedures, FABD has also produced the Coach Education Policy, the Internal Organisation Regulations, Electoral Codes, Post Covid-19 guidelines, return of football and lastly, the Post Covid-19 Football National Team Training Protocol & Procedures.






RAISING THE DOME





FABD COMPETITIONS DEPARTMENT ACTIVITIES IN 2022

Brunei entered the early endemic phase of its COVID-19 recovery plan on 15th December 2021 which saw the sultanate starting to loosen restrictions on public life caused by the COVID-19 pandemic albeit with certain limitations.

However, Brunei Darussalam ceased its early endemic phase officially on 31st May 2022, with updated COVID-19 guidelines put into effect on 1st June 2022, which allowed for public mass gatherings to be conducted without limitations, and this included all sporting activities including competition or matches.

In light of this, the Competitions Department of the FABD and football clubs on match organisations FABD were only able to organise three activities in 2022. which include the FIFAe Nations 2022, the Brunei Futsal Cup 2022 and the Brunei FA Cup 2022.

FIFAe NATIONS 2022

The FIFAe Nations 2022 is an esports tournament series organised by FIFA and was participated by 86 countries across the globe including the sultanate

During this activity, the FABD worked in collaboration with the Esports Association of Brunei (ESB), working with some of the country's most talented e-athletes and saw Brunei Darussalam qualifying for the FIFAe Nations 2022 Main Stage.

Brunei Darussalam also qualified for the next round against Indonesia and New Zealand but ultimately, did not qualify for the FIFAe Nations Cup 2022, with the sultanate closing out the competition ranking 79 out of the 86 participating countries.

















License Applicants are responsible for ensuring that deadline. the FABD is provided with all the necessary information and/or documents relevant to proving that licensing obligations are fulfilled, as these obligations relate to the criteria set out under the club licensing regulations.

Under the FABD's Club Licensing System, the association has two decision-making bodies which will decide on the application and hear appeals on the granting of a license to the applicants. These aforementioned bodies shall be independent of each other and the members shall not have any conflict of interest.

Members of the decision-making bodies are equipped lawyer and a qualified accountant/auditor. with the relevant knowledge of professional football as

> The AB makes its decision based on the documents submitted before the FIB therefore no new documents or evidence shall be admitted. Subsequently, appeals may be lodged by;

- -The license applicant club, who received the refusal of the FIB
- -The licensee club, whose license has been withdrawn by the FIB
- -The Licensing manager of the National Football Association or its affiliated Football league










LIST OF LICENSE APPLICANTS

FUTURE PLAN 2023

Moving forward, the FABD aims to conduct on-site visits to the Club Secretariat Office and training grounds as well as introduce and promote club licensing among Brunei's Futsal clubs. FABD will also be collecting data for the top-tier clubs in Brunei while analysing the development of the Club Licensing Tier-2 (District) Clubs.

FABD will be conducting a One-on-One refresher course with the clubs' club licensing managers and will create the Club Licensing section on the FABD website which will provide all the relevant documents that all users can access.

The FABD will be upgrading the added criteria which will be implemented in the National and AFC Club License processes and following the club licensing cycle of 2023/2024 will focus on the Top Tier League in Brunei.

The FABD will also be renewing the Strategic Plan for Club Licensing 2022 - 2026 and will be proposing a permanent position for the Club Licensing Officer role as required in the CLS to get access to the CLAS system and access to all the documents.

MARKETING & COMMERCIAL ANNUAL REPORT 2022 (COMMENCING Q3 - Q4 2022)

The FABD Marketing Department's Mission Statement is to help the association grow its revenue, improve its marketing strategy and build up the association's branding through the use of sports marketing.

FABD has identified its target audience for its marketing strategy and the target demographic is majority male as 60% of spectators during league games are men between the ages of 35 and 60 while 70% of spectators during national team games are men aged between 20 to 60.

Two (2) additional sponsors were also secured by the end of 2022, which will hopefully be utilised in the next year's league; the Brunei Super League 2023.

Building Capacity FABD is looking to organise at least two (2) workshops per year, focusing on branding and marketing, which will hopefully involve all four districts in Brunei Darussalam. The association will also develop a training programme for clubs on marketing and communications through social media.

ENGAGING FANBASE

The association has been improving its digital content across all platforms. By developing a content plan and identifying ways to amplify said content, FABD was able to grow its social media followers, especially Instagram throughout the year.

Currently, the @fa.bruneidarussalam Instagram account has more than 8,000 followers. FABD hopes to achieve at least a 30% growth from last year's figures across all its social media platforms.

Growing Attendance at Games FABD has been steadfast in growing the attendance of spectators at men's national and domestic games through annual marketing campaigns where the association has now managed to achieve an attendance expectation of more than 50%.





Part of FABD's efforts in ensuring greater attendance include profiling local clubs across all marketing channels to garner interest among the local population. The profiles can be found posted on the FABD website.

The association has also been streaming and broadcasting league games through the mobile application RTBGO since the friendly match tournament back in October 2022 which has garnered viewers from outside of Brunei Darussalam.

Building the Association's Brand FABD is already looking into developing a brand guidelines document with a key message and tone already set in place. The key message and tone of voice were launched successfully for grassroots and BFA events as the FABD ensures coverage on social media for grassroots, schools and youth football activity. Grassroots's latest video updates can be found on our YouTube channel.

Ultimately, to ensure the success of FABD's marketing plan, the association is familiarising itself with new strategies, for instance, a guid pro guo concept with partners and sponsors to strengthen the working relationship.

Furthermore, through the internet, FABD can market FUTURE PLAN 2023 its events better, allowing fans and supporters to be upcoming events.

AFC/UEFA ASSIST MARKETING PROGRAMME

The AFC / UEFA Assist Marketing Programme kicked off in December, which aims to assist Football Associations In terms of sports event organisation, the association (FAs) in crafting their marketing strategies to build a better digital presence for its stakeholders. FINANCE DEPARTMENT

The Finance Department is responsible for financial and budgeting, procurement, financial reporting and accounting. In addition, the finance department is responsible for maintaining the financial integrity of FABD by developing and ensuring compliance with the following policies:

- Brunei Darussalam Accounting Standard Non-Public Interest Entities (BDAS-NONPIE).
- · Finance Policy that is implemented.
- · FIFA Forward program regulations.
- · AFC Enhance Program rules and regulations.

ACTIVITY

A Circular was received on 31 October 2022 from the Asian Football Confederation (AFC) informing that the AFC Enhance Programme regulations which is now in force have premised on the AFC enhance Member Association Programme Regulation and policy.

Following the successful implementation of the AFC Enhance Member Association Programme, a review was carried out to further improve the governance, accountability and transparency of the distribution of development funds to the Beneficiary Member Associations.

This report outlines the activities of the finance. In summary, both regulations and policies have been consolidated into the Enhance Programme Regulations which simplifies the content and form and establishes it keeps moving forward. Additionally, our department a more transparent regulatory framework while making

The Key Highlights of the Regulations are as follows:

Programme

The AFC Enhance Member Association Programme and the AFC Enhance Regional Association Programme have been renamed as the AFC Enhance Programme - a consequential change to the title of the AFC Enhance Member Association Programme and the AFC Enhance Regional Association Programme Regulations and Policies.

Scope of Application

The Regulations govern the management of funds and shall be for a four (4) year cycle from 2021 to 2024.

Objectives

The Enhance Programme is designed to facilitate the strategic and long-term football development through the provision of funding for activities or projects, which are anchored on the nine (9) tenets of football development namely: Kick-Off, Pass, Volley, Stadium, Advantage, Extra-Time, Backroom, Equaliser and Penalty.

Scope of Application

Financial assistance of up to USD 2 million for a four (4) year cycle (2021-2024) with a maximum allocation of USD500,000 per year per Beneficiary MA to be utilised for activities or projects under Kick-Off, Pass, Volley and Stadium.

Financial assistance of up to USD 300,000 with a maximum allocation of USD150,000 per year per Beneficiary MA to be utilised for activities under Advantage.

To benefit from the funding under Advantage, a Beneficiary MA's annual total income should not exceed USD 5 million (USD5,000,000).

Financial assistance of up to USD 100,000 with a maximum allocation of USD50,000 per year per Beneficiary MA to be utilised for activities under Extra-Time.

To benefit from the funding under Extra-Time, a Beneficiary MA's annual total income should not exceed USD 3 million (USD3,000,000).

Eliqibility

Suspended Member Associations ("MA") and MAs whose country or territory is subject to international economic, financial and/or other sanctions/restrictions shall not be eligible to join the Enhance Programme.

Conditions of Use

Beneficiary MAs can utilise the funds in four (4) main areas:

- Kick-Off Administrative Salaries and Operational Expenses
- Pass Men's Competitions
- Volley Women's Competitions
- Stadium Infrastructure

Monitoring

The AFC will conduct annual central audits on all Beneficiary MAs and Beneficiary Ra's.

Release of Funds

1st Payment – 50% of the total Enhance Programme Fund upon approval of the application and 2nd payment - 50% of the total enhance program upon completion of the central audit.

The unutilised budget will be rolled over under the infrastructure (stadium). The finance department together with the General Secretary's office has submitted the application for 2023 under the AFC enhance the programme, the key information is as follows:

AFC Enhance programme - Kick-off, Pass, Stadium, a total of USD 425,000 application has been submitted under the mentioned programme, however, unfortunately, the volley cannot be applied as it did not meet the requirements.

This application funds support the administrative, and operational costs, the Brunei Super league costs, Futsal costs, and the floodlight project. In addition, under the advantage programme, FABD has requested the contribution of funds for the Head coach of the Brunei National Team, Technical staff and football equipment totalling to USD 95,836.

In addition, the extra-time application has been submitted with a total of USD 50,000 for the purchase of football equipment. In 2022 under the AFC enhance member association programme -Under the application Enhance, a total of USD 500,000 were allocated into four categories in which administrative operation costs, salary, Men's competitions, Women's football activity and Infrastructure.

The Advantages programme has been utilised to support the cost of our local coaches, technical staff, AFC coaching convention and football Equipment with a total of USD 91,650

Under Extra-time, football equipment has been applied under this programme with the total amount of USD 49,851 to purchase the national team kits such as U16, U17, U18, U19, and Senior Men's.

FIFA FORWARD PROGRAM

FIFA introduced the FIFA forward Program 2.0 back in 2019 which will end in 2022. It was reported in the 2021 FABD Financial report that BND 683,875 was brought forward to 2022 to support the operation of the football administration in Brunei Darussalam. FABD has laid out a strategic program for the development of football in Brunei Darussalam.

The Grants received in 2022 have been supporting the activities that FABD conducted which relate to football matters such as preparation of the National Team, Brunei League competitions, Grassroot, Youth development and others.

Apart from the FIFA forward 2.0 operational Grants, FABD is also entitled to Travel grants 1.0 amounting BND 704,018 to support the National Team on their travel outside camp and competitions.

Additionally, a grant under FIFA forward 2.0 Travel wasreceived to finance the cost of the National Team going abroad.

FIFA FORWARD PROJECT 1.0 & 2.0

CONCLUSION AND RECOMMENDATION

In conclusion, in 2022, the continuation of the second Covid-19 wave has been challenging for the finance department to have a finance function routine.

When the Covid-19 restrictions were lifted during the second quarter of 2022, football activities resumed after inactivity for close to a year.

The finance department contributed their best effort to make the activities smooth and successful.

The construction of the Technical Center and mini grandstand construction was completed in 2022 and football stakeholders are now able to utilise the premise and benefit from the equipped facilities.

This year, FIFA released the travel grants for 2020 that were postponed due to the Covid-19 pandemic. They also made the FIFA forward 1.0 travel available and encouraged it to be utilised in 2022. The National team seized the opportunity and actively went abroad for competitions and training camps.

In response to the audit findings for 2021, it recommended to layout SOP and Policies to control the process for the smooth operation of football administration.

It is also a football stakeholder's responsibility to manage and properly utilise the financial support provided by the governing football body. Taking into account, in the pursuit of good governance, requires the football community to be cooperative and accountable to bring the positive development of football in Brunei Darussalam.

In addition, FABD continuously constructs policies and procedures to tighten internal control to prevent violating rules and regulations.

The initiative of FABD to lay out programmes for Income generation in furtherance of expanding and funding the cost of football activity here, in Brunei Darussalam.

Having income generation as well enables FABD to run independently without depending on grants from the international football body governing.





- 4. We need lots of funding from other associates. Good news is some generous donors have come forward. For example: Imagine. Thank you sponsors.
- 5. Our budgeting committee and secretariat are now in strong discussion with other potential sponsors and we hope there will be more generous hands coming forth to assist us.
