The Interim President welcomed esteemed members of FABD, District Associations, Representatives of the local football clubs to the Ordinary Congress.

The Interim President has declared that the FABD Ordinary Congress has officially been convened and composed in compliance with the necessary FABD Statutes, and thus declared the congress open.

After the Roll Call, the Interim President informed the floor that FABD has received two (2) resignation letters from the Executive Committee namely Pg Jamilah binti Pg Haji Zanin and Pg Haji Jufry bin Pg Haji Jaludin on 21st November 2024 and 12th December 2024 respectively.

In addition to that, an Executive Committee meeting had been convened on 25 November 2024 to provisionally dismiss Hj Feisal Eusoff Patail as the FABD President, which is in accordance with Articles 17, 18 and 24 of the FABD Statutes. The Interim President then informed the floor that the agenda to decide on removing Hj Feisal Eusoff Patail from his Presidency seat will be on agenda item number 12.

Interim President Haji Mahrub has also officially announced his resignation as the FABD Deputy President effective 16 December 2024 and has submitted the resignation letter to FABD. The resignation letter was displayed on the screen.

Opening Address by Interim President

The Interim President introduced his speech by expressing gratitude for the 17 people who had voted him as Deputy President. He then started listing out FABD's achievements (especially Brunei's rise in FIFA ranks i.e. from 194 to 183) as it is almost a year since the last election for the current members of executive committee was held. He thanked the related parties who had assisted in these successes such as DPMM FC, Kasuka FC, Indera SC with guidance and support from AFC, FIFA, KKBS.

behind the successes there have been Unfortunately, multitudes of obstacles - from uncooperativeness between EXCO, Congress Members and FABD Secretariat staff, to false rumors, to personal issues involving social media usages. He understands that the majority of the affiliated clubs do not have good governance due to lack of sources, including funds, staff, players and coaches. He also brought up the EXCOs inability to work together, with infrequent presence, passive participation and unfulfilled duties. Additionally, he mentioned FABD Secretariat's lack of integrity with rumors of financial funds that induced a mass resignation - and even questioned a possibility of sabotage.

He reiterated that despite everything, they had completed the year with what they had planned to achieve and he wished the best for FABD for future endeavours - whether with improvements or not.
